# What is Teen Intervene?

Teen Intervene program helps youth and teens identify the reasons for their alcohol and drug use, provides personalized course of action to make healthier choices and offers education in the following areas:

- ◆ Identify the pros and cons of their use.
- ◆ Identify the reasons they use.
- ◆ Learn new skills to promote healthy behaviors
- ◆ Take responsibility for self-change.

## Why am I being referred to Teen Intervene?

This program is designed to provide the underage offender an alternative. It is designed to offer an opportunity to take a hard look at behavior in terms of alcohol usage.

Offenders under the age of 21 who have been cited for an alcohol-related violation (State Statute 125.07(4)(a)) and are required to appear in court have two options:

1. Have your drivers license suspended and be assessed a forfeiture or,
2. Comply with the Underage Drinking Diversion Program-Teen Intervene.



## What does Teen Intervene require for successful completion?

- Step 1** A brief phone screening to determine appropriateness.
- Step 2** Two 120 minute group sessions
- Group 1**  
Introduction, establishing ground rules  
Pros and Cons  
Triggers and Cravings
- Group 2**  
Readiness to Change, establishing goals  
Readiness to Change 2, peer pressure decision-making skill
- Step 3** Parent/Guardian Session-by appointment and mandatory for anyone under the age of 18
- 6-Steps Exercise  
Family Rules on alcohol or other drug use  
Parent/Guardian goals

### What incentive is there for me to participate in this program?

#### First Lifetime Offender:

If you choose to participate in the Underage Drinking Diversion Program and comply with the recommendations, your driving privileges will not be suspended and you will receive a reduced forfeiture.

#### Second Lifetime Offender:

If you complete an Alcohol Assessment and follow the recommendations, you will receive a minimum suspension of your driver's license and a reduced forfeiture.

If you fail to comply with the recommendations of the program, you will be assessed a forfeiture, court costs, have your drivers license suspended, and be responsible for the reinstatement of your driver's license.
